Q. How many types of self registration?

Ans: Farmer, Society, Entrepreneur and Manufacturer.

Farmer

Q. What are the required documents for the farmer registration?

Ans: Aadhar card, Record-of-right of land, Passport Size Photograph, Copy of Bank Passbook, Copy of Id Proof (except Aadhar Card), Copy of cast category certificate (in case of SC/ST/OBC).

Q. Required field to be selected while registration?

Ans: Farmer while registering in DBT portal has to select correct District, Sub-District, Block, and Village from the drop down list. The name of farmer should be as per Aadhar card. The farmer category (SC/ST/General), farmer type (Small/Marginal/Large) and Gender (Male/Female) should be correctly furnished otherwise the application will be debarred at the time of physical verification. This is the responsibility of farmer to furnish the correct details for availing subsidy.

Q. How does a farmer can check his registration?

Ans: For this choose one category of following:

Registration=>Farmer

- Aadhar Number
- Mobile Number
- Name of Farmer

Q. Is mobile no. is mandatory in registration?

Ans: Yes, you will get the OTP for registration and also notify by portal on each transaction.

Q. Who will getting the subsidy?

Ans: Farmer or Dealer can get the subsidy. But it will be selected by the dealer at the time of uploading the bill of implement.

Q. Is Bank detail required for Farmer?

Ans: Yes, farmer is mandatory to add bank detail to get subsidy.

Q. What to do if bank branch name and IFSC code is not found?

Ans: In this case, must be talked to the respective state nodal officer. State nodal officer has privilege to add branch name and IFSC code in their login.

Q. Can farmer to be benefitted one and one or more time in same financial year?

Ans: Its only depend on the state wise that they can be benefitted or not and it also depends, whether he /she may be benefitted on the same implement after certain period.

Q. What are the compulsory field to filled by the farmer before apply for implement?

ANS: Farmer before apply for implement the compulsory field to be filled (like Add land detail, Add bank detail)

Q. Can farmer update registration details?

Ans: **Yes.** If some error has occurred during successful registration (like Gender, DOB, Mobile No., Category, Bank detail and land detail) then farmer can edit or update his/her detail if he not applies any implement, If he has already applied the implement then, he can update detail only after withdrawal of the previous application of implement.

Q. Does farmer can update profile once he/she got benefitted?

Ans: No, If farmer has already benefitted their record cannot be modified, if State nodal officer request for that then it can be considered.

Q. Can I change registered mobile number?

Ans: Yes, You can change it but it will be verified old and new mobile number.

Q. How do I get to be notified when registration can be done ?

Ans: Once completion of registration a popup message will be shown on display screen and also getting a message on registered mobile number

Manufacturer

Q. How can be Manufacturer register?

Ans: Manufacturer can be registered by itself.

Q. Does a manufacturer can be registered state wise?

Ans: No, one time registration can be done where the corporate office present in respective state.

Q. Does GST No is required?

Ans: Yes, also upload the copy of GST certificate.

Q. Does TIN Number or PAN number is required?

Ans: No.

Q. Do manufacturer required separate registration for dealer?

Ans: No, not required separate registration for manufacturer to be dealer. Whether he should be selected the dealer option under the manufacturer profile.

Q. How to add Product?

Ans: Go to the Product module under manufacturer's login then click on Add Product link.

Q. Is Testing Report is mandatory for product?

Ans: Yes.

Q. Can I add the MRP price state wise?

Ans: Yes, manufacturer can add price state wise and also throughout all India.

Q. Is manufacturer/dealer can be increased MRP/Dealer price at any time?

Ans: Once MRP is approved by respective state nodal officer, manufacturer cannot be increased the price after approved, it can be decreased only. Dealer price cannot be more than MRP and once the price approved then it can be decreased only.

Q. How to manufacturer map the product with dealer?

Ans: Under manufacturer's login, go to Existing Dealer can map the products to dealer in their jurisdiction area.

Q. How can be approved the Manufacturer Firm, Product and MRP?

Ans:- MRP price will be entered financial year wise then respective state nodal officer will be approved the manufacturer firm, product and MRP.

Q. Can manufacturer change the product category?

Ans: No.

Dealer

Q. Can dealer do the self registration?

Ans: No, Manufacturer will be registered the dealer or existing dealer can be inherited by the manufacturer, if any.

Q. Is GST mandatory for dealer?

Ans: Yes, upload copy of GST certificate.

Q. Does TIN Number or PAN number is required?

Ans: No, It is not mandatory, can be uploaded.

Q. Can a dealer work with multiple manufacturers?

Ans: Yes, If a dealer is already registered with another manufacturer, he may also be inherited by other manufacturer.

Q. How to register a service center?

Ans: When the manufacturer mapped the products to the dealer, that time service center can be registered/made.

Q. Who can be renewed the Dealership Validity period?

Ans: Dealership validity will be renewed by the manufacturer for respective product.

Q. Who can allocate area of operation for dealer?

Ans: Manufacturer will allocate area of operation to the dealer.

Q. What is approval process of Dealer Product?

Ans: Manufacturer will be mapped the products to the dealer and allocate area of jurisdiction to the dealer, then dealer will be entered the dealer product price after that district officer will be approved the product and dealer price.
